TimeAlly Club Website Terms and Conditions of Service

Last Updated: 12 January, 2019

Welcome to TIMEALLY CLUB Website and our Terms of Service (“Terms”). These Terms are important and affect your legal rights, so please read them carefully. Note that Section 13 of these Terms contains a mandatory arbitration provision that requires the use of arbitration on an individual basis and limits the remedies available to you in the event of certain disputes.

By accessing or using the websites (<https://www.timeallyclub.com/>), mobile applications, and wallets (collectively, the “Sites”) or Services provided by TIMEALLY CLUB that link to these Terms, you agree to be bound by these Terms and all of the terms incorporated herein by reference. If you do not agree to these Terms, you may not access or use the Sites or Services.

The services provided by TIMEALLY CLUB (the, “Services”) is well mentioned on the website. These Terms govern your access and use of the Sites, and your use of such Services. Note that the Sites and Services are not a guarantee against identity theft or online identity fraud and are not a substitute for online security software.

These Terms do not alter in any way the terms or conditions of any other agreement you may have with us in respect of any products, services or otherwise. If you are using the Sites or Services on behalf of any entity, you represent and warrant that you are authorized to accept these Terms on such entity’s behalf and that such entity agrees to be responsible to us if you or such entity violates these Terms.

TIMEALLY CLUB reserves the right to change or modify these Terms at any time and in our sole discretion. If we make changes to these Terms, we will provide notice of such changes, such as by providing notice through the Sites or updating the “Last Updated” date at the beginning of these Terms. By continuing to access or use the Sites or Services, you confirm your acceptance of the revised Terms and all of the terms incorporated therein by reference. We encourage you to review the Terms frequently to ensure that you understand the terms and conditions that apply when you access or use the Sites or Services. If you do not agree to the revised Terms, you may not access or use the Sites or Services.

TimeAlly Club Card –

TimeAlly Club Card services are governed by these Terms of Use. Please read the following terms and conditions carefully before registering, accessing, browsing, downloading or using the Site (defined below) and/or Era Swap Application. By accessing or using the Application or Site or by using the Services (defined below), you agree to be bound by these terms and conditions set forth below including any additional guidelines and future modifications. If at any time you do not agree to these terms and conditions or do not wish to be bound by these terms and conditions, you may not access or use the site and immediately terminate your use of the services.

Opening Era Swap Wallet

In order to use our Era Swap wallet services, you must first create Era Swap account. As part of the signup process, you will need to accept these Terms of Use and our Privacy Policy and you must have legal capacity to accept the same. If you order additional services, you may be asked to accept additional terms and conditions.

By creating Era Swap account, you represent and warrant to us that your opening of Era Swap does not violate any laws or regulations applicable to you. You shall indemnify us against any losses we incur in connection with your breach of this section.

To be eligible to use Era Swap products, you must be at least 18 years old. For minors, you shall provide a consent form duly completed by your parent/legal guardian along with your and their identification documents.

All information you provide during the signup process or any time thereafter must be accurate and truthful.

Funding your TimeAlly Club Card

You can fund your TimeAlly Club Card card by logging into Era Swap and following the relevant funding instructions mentioned on the website. You can use your TimeAlly Club Card to add fund to your Era Swap wallet.

Third parties are strictly prohibited to add funds in your dedicated account. If we determine that the account have been funded by third parties, the fund will not be recognized and will be set on hold for proper handling of prohibited activity.

You may be asked to answer security questions or to complete other activities that we may reasonably require to ensure proper authorization of a funding transaction.

Funds may be subject to limits due to security and legal requirements.

Funding is subject to fees and currency conversion fees.

Sending Funds

To send fund you are required to authorize the sending of funds with your login details and password. We may also ask you additional security questions relating to you or your Era Swap account.

Every recipient of fund you wish to send must have an active Era Swap.

The fund sent will be deducted to your Era Swap and will be added to the Era Swap recipient when you confirm the sending fund transaction.

Sending funds is subject to fees and currency conversion fees.

Payment of Goods and Services

The value funded to the Era Swap Wallet may be used to purchase goods and services from Era Swap Accredited Merchants using the Era Swap fund transfer executed by the Era Swap user in Era Swap application.

You hereby acknowledge and accept that any goods or service bought using Era Swap token is a matter between you and the relevant merchant. We do not act as an agent or representative of any Era Swap holder or merchant. Any claims you may have relating to your transactions that are not directly related to the payment process must be directed to the relevant merchant.

We do not accept any claim for chargeback (reverse payment) as this is a matter between you and the relevant merchant.

Receiving Funds

If you receive funds into your Era Swap, we will send you a notification e-mail and display the transaction in your online statement. You should regularly reconcile incoming funds with your own records.

Cash Out

You can Cash out of all or part of the funds held in your Era Swap at any Era Swap cash out partners during business hours.

You must ensure that the payment details you enter when withdrawing funds are correct and complete.

Fees

Transaction related fees can be viewed at any time in the "Fees" section of our Website/Application.

Refund

You must send a written request to support@eraswaptechnologies.com using your registered email address for any refund arising out of or in connection with your use of your Era Swap Account. Era Swap reserves the right, at its sole discretion, to deny any refund request received from unregistered email address and other communication platform or for any other reason as we deem fit.

If you have a balance left in your Era Swap account that you wish to claim, you may at any time use the cash-out or send features of your Era Swap account unless we deliberately suspended or terminated your account due to violation in any part of this terms and if the law prohibits us from releasing the funds to you.

In case you are eligible and granted a refund, any refund will be made using the same method that you used or another method at our discretion.

Regulation of connecting to Third-party

To provide more services, Era Swap provides selected connections to other websites and business enterprises. These connections help you to trade, transact, and pay more conveniently with third-party.

You further acknowledge and agree that We shall not be responsible for any direct or indirect damage related to products and/or services provided by any third-party website or services.

Binding Arbitration

Except for any disputes, claims, suits, actions, causes of action, demands or proceedings (collectively, "Disputes") arising out of or related to a violation of Section 8 or Disputes in which either party seeks to bring an individual action in small claims court or seeks injunctive or other equitable relief for the alleged unlawful use of intellectual property, including, without limitation, copyrights, trademarks, trade names, logos, trade secrets or patents, you and TIMEALLY CLUB agree (a) to waive your and TIMEALLY CLUB's respective rights to have any and all Disputes arising from or related to these Terms, or the Sites, Content or Services, resolved in a court, and (b) to waive your and TIMEALLY CLUB's respective rights to a jury trial. Instead, you and TIMEALLY CLUB agree to arbitrate Disputes through binding arbitration (which is the referral of a Dispute to one or more persons charged with reviewing the Dispute and making a final and binding determination to resolve it instead of having the Dispute decided by a judge or jury in court).

No Class Arbitrations, Class Actions or Representative Actions

You and TIMEALLY CLUB agrees that any Dispute arising out of or related to these Terms or the Sites, Content or Services is personal to you and TIMEALLY CLUB and that such Dispute will be resolved solely through individual arbitration and will not be brought as a class arbitration, class action or any other type of representative proceeding. You and TIMEALLY CLUB agrees that there will be no class arbitration or arbitration in which an individual attempt to resolve a Dispute as a representative of another individual or group of individuals. Further, you and TIMEALLY CLUB agree that a Dispute cannot be brought as a class or other type of representative action, whether within or outside of arbitration, or on behalf of any other individual or group of individuals.

Notice; Informal Dispute Resolution

You and TIMEALLY CLUB agree that each party will notify the other party in writing of any arbitration or small claims Dispute within thirty (30) days of the date it arises, so that the parties can attempt in good faith to resolve the Dispute informally. Notice to TIMEALLY CLUB shall be sent by certified mail or courier to TIMEALLY CLUB. Your notice must include (a) your name, postal address, telephone number, the email address you use or used for your TIMEALLY CLUB account and, if different, an email address at which you can be contacted, (b) a description in reasonable detail of the nature or basis of the Dispute, and (c) the specific relief that you are seeking. Our notice to you will be sent electronically and will include (x) our name, postal address, telephone number and an email address at which we can be contacted with respect to the Dispute, (y) a description in reasonable detail of the nature or basis of the Dispute, and (z) the specific relief that we are seeking.

If you and TIMEALLY CLUB cannot agree how to resolve the Dispute within thirty (30) days after the applicable party receives the notice, then either you or TIMEALLY CLUB may, as appropriate, commence an arbitration proceeding or, to the extent specifically provided for in Section 13.1, file a claim in court.

Process

Except for Disputes arising out of or related to a violation of user conduct or Disputes in which either party seeks to bring an individual action in small claims court or seeks injunctive or other equitable relief for the alleged unlawful use of intellectual property, including, without limitation, copyrights, trademarks, trade names, logos, trade secrets or patents, you and TIMEALLY CLUB agree that any Dispute must be commenced or filed by you or TIMEALLY CLUB within one (1) year of the date the Dispute arose, otherwise the underlying claim is permanently barred (which means that you and TIMEALLY CLUB will no longer have the right to assert such claim regarding the Dispute).

Governing Law and Venue

These Terms, your access to and use of the Sites and your use of the Services shall be governed and construed and enforced without regard to conflict of law rules or principles that would cause the application of the laws of any other jurisdiction. Any Dispute between the parties that is not subject to arbitration or cannot be heard in small claims court, shall be resolved in the higher court.

Termination

Notwithstanding anything contained in these Terms, we reserve the right, without notice and in our sole discretion, to terminate your right to access or use the Sites and to use the Services, at any time and for any or no reason, and you acknowledge and agree that we shall have no liability or obligation to you in such event and that you will not be entitled to a refund of any amounts that you have already paid to us, to the fullest extent permitted by applicable law.

Severability

If any term, clause or provision of these Terms is held invalid or unenforceable, then that term, clause or provision will be severable from these Terms and will not affect the validity or enforceability of any remaining part of that term, clause or provision, or any other term, clause or provision of these Terms.

Miscellaneous

These Terms constitute the entire agreement between you and TIMEALLY CLUB relating to your access to and use of the Sites and your use of the Services. These Terms, and any rights and licenses granted hereunder, may not be transferred or assigned by you without the prior written consent of TIMEALLY CLUB prior, concurrent or subsequent circumstance, and TIMEALLY CLUB's failure to assert any right or provision under these Terms shall not constitute a waiver of such right or provision. Except as otherwise provided herein, these Terms are intended solely for the benefit of the parties and are not intended to confer third party beneficiary rights upon any other person or entity.
